The undersigned dealer and employees expressly releases the GSNA staff and employees from any and all claims or responsibility for any personal or business losses, damages, or injuries that may occur from any cause prior to, during, or after the periods covered by this contract. The foregoing shall not limit liability of any individual guilty of theft, willful damage, or destruction.
4. The undersigned dealer agrees to abide by all rules and regulations of the Ukrainian Cultural Center, in particular their parking regulations and no-smoking policy.
5. A **two lamp limit per 8-foot table** will be strictly enforced to prevent electrical problems.
